Residential Unmetered Water Delivery Rate to Members Money paid to the Company for delivery of water to Members' parcels	\$240 per quarter
Other Unmetered Water Delivery Rates to Members To compute rates for commercial, institutional, multi-unit, etc.	See Art. VIII, Section 2 of 1996 Bylaws
Standby Charge (Residential) Money paid to the Company for maintenance and future availability of Service Connections not currently in use	\$135 per quarter
Membership Interest Transfer Fee Money paid to the Company to transfer a parcel's Membership Interest. It is applied whenever the parcel's transfer is also recorded with the Alpine County Recorder.	\$45
Rate for Bulk Water Delivery to Public Agencies* 1,000-gallon minimum charge + actual administrative costs. Not pro-rated No charge if used by a Fire Department for fire suppression What constitutes a bulk delivery to a public agency that is also an MWC Member shall be at the sole discretion of the MWC Board of Directors	\$6.67/1,000 gallons
Standard Connection Fee (Up to 1-inch residential) Money paid to the Company when Member initially extends service from a Company-owned Service Connection to a structure or other point of use on a Member-owned parcel	\$300
Charge for Additional or Oversized Service Connections Extra or oversized connections may be installed only by the Company with costs reimbursed by Member.	\$300 + Actual Cost of Installation
Charge for Operation of a Curb Stop by a Company Agent Money paid by a member to the Company to shut off or turn on water service for any reason.	\$200
Penalty for Operating or Tampering with Any MWC Facility, Including MWC's Curb Stop Valve at a Member's Service Line <i>(plus the cost to repair any damage that may have resulted in the operation)</i>	\$400
Charge for a Hydrant Test Money paid to the Company for one hydrant pressure test	\$450
Application Fee for a Membership Interest Money paid to the Company when applying to acquire a Membership Interest	\$200
Charge to temporarily extend service from one member-owned parcel to another Permission to extend is at discretion of the Board of Directors. One-month minimum, not pro-rated	\$50 per month
Initial Penalty for Payment Delinquency (30-day late charge)	10% of amount owed
Interest Charge thereafter on Overdue Balances	1.5% per month, compounding
Charge to Post or Mail a Ten-day Shutoff Notice	\$50

*California Corporations Code §14300 prohibits the sale of MWC water to any private entity other than its Members except in specified emergencies.
